**Keynote Title:** The More-than-Human Worlds of Self-Tracking for Health and Fitness

Sociology of Sport, like its parent discipline Sociology and the Social Sciences more broadly, is facing unprecedented challenges not only over funding and resources, but also in terms of its legitimacy and relevance. Within the context of neoliberalism in general, and the corporatisation of university education in particular, there has been a slow but steady marginalisation of sociology of sport as a field of academic study. Curiously this has occurred despite enormous growth in the interest in ‘sport’ (broadly defined) within the global economy and as a focus of scholarly enquiry. Both the state and private interests are increasingly aware of sports’ strategic location at the intersection of key sectors of society including: education, health, business and tourism/nation branding. Moreover, scholars

spanning the fields of sociology, anthropology, history, geography, politics, economics, media and communication studies, and gender studies are increasingly recognising the social significance of sport as a cultural form and practice.

As we approach the 20th year of the new millennium, the 2019 World Congress of Sociology of Sport provides an ideal platform to reflect, evaluate and contemplate the past, present and future of the field. While the sociology of sport, across all of its specialisations, has successfully identified social fault lines within sport, discussions about how to use this knowledge for social transformation and social justice through collective action and social policy have been far less robust. In short, it is timely for our field to envision and create an alternative future for both sport and its sociological analysis.

The 2019 Congress offers a unique opportunity to consider how, in the spirit of C. Wright Mills, our research, teaching, public service and political activism, can connect private experience with wider social structures, personal problems with public issues, and scientific analysis with political awareness. We invite scholars to share their research and to consider how it might contribute to a new vision for sport, exercise, physical activity and health.

#### Call for Research Articles

The *IRSS* encourages the submission of diverse research articles seated in the sociology of sport, broadly defined, that shed light on social and cultural understandings of sport. Interdisciplinary, inclusive, and global, the *IRSS* is the journal of the International Sociology of Sport Association and is published in partnership with SAGE Publications. Please visit the journal website for more information about its Aims & Scope, the Editorial Board, manuscript submission guidelines, and sample issues at <http://journals.sagepub.com/home/irs>

The *IRSS* publishes eight issues each year. To help expedite the review and publication process, the *IRSS* uses the SAGE Track online manuscript submission site powered by ScholarOne Manuscripts. Scholars submitting manuscripts for consideration can expect a prompt double-blind review process that draws on the expertise of a diverse editorial board and a worldwide network over 3000 expert area scholars. While we expect in the region of 300 submissions per year (including revised manuscripts) we operate a highly efficient process such

that the majority of decisions on manuscripts are issued within 40 days of submission. The journal's use of the SAGE OnlineFirst publication program means that accepted manuscripts are usually made available to the scholarly community within weeks of acceptance. New Content alerts and exposure on the Sage Sociology Twitter channel (with around 34,000 followers) means that publication in the *IRSS* provides authors with an excellent opportunity to get scholarly work promptly disseminated to international audiences.

#### Book/Media Reviews

The *IRSS* welcomes Kass Gibson as the new media/book reviews editor and again gives heartfelt thanks to David Leonard for his years of service in this role.

While the *IRSS* has a longstanding tradition of publishing insightful reviews of research monographs, it must be responsive to publishing trends. The growing prominence of sporting documentaries and docudrama means these have become increasingly important as means through which people are prompted to reflect on social and cultural practices and understandings of sport. Therefore, at this time, we especially welcome review of media works.

ISSA members will also notice a significant increase in the publication of edited collections. Given the size of edited collections we also seeking reviewers to conduct comparative reviews of such works. - Any student who is registered for master or doctoral level graduate work at the time her or his paper is submitted.

## Awards

- The **winning author** will be invited to attend the Eass conference free of charge and to **present the paper to the plenary session** during the closing ceremony, in which they will receive a **€500 monetary prize** sponsored by Eass.
- Eass sponsored prize of **membership in Eass** for the year after which the award is also granted.
- The panel of judges may also give one **honourable mention**. Young researchers receiving an honourable mention will also have their papers accepted for presentation in a parallel session at the Eass conference free of charge and will receive a **€250 monetary prizes** sponsored by ENGSO Youth.

## Requirements

- Candidates will submit a scholarly paper on a topic that is of interest to the European sociology of sport academic community. Please submit **two separate files**: the first one must contain the title of the paper and the full contact information of the author; the second one must contain the title, the abstract and the full text of the paper (here the author should remain anonymous).
- Papers with a **length** of over **8,000 words (references included)** will not be considered.
- Papers must be **original**, i.e. not already submitted elsewhere.
- Authors will submit a letter, signed by her or his academic advisor, verifying their student status or the date of their PhD dissertation (not earlier than 5 years before the time her or his paper is submitted).
- Authors will comply with the publications guidelines of EJSS (see: [http://www.tandfonline.com/action/authorSubmission?show=instructions&journalCode=r\\_ess20](http://www.tandfonline.com/action/authorSubmission?show=instructions&journalCode=r_ess20))
- Papers should be sent to the Award Committee Chair in electronic copy (Microsoft Word).

**Information:** Issues related to development and sport often find themselves center-staged within the broad field of social sciences in sport. However, this relatively young academic field seems to struggle to generate new fundamental theoretical insights about how organized sport can both act as an inclusive space and a vehicle for broad developmental outcomes. Questions how the field could go beyond the current state-of-the-art are seldom asked or discussed within academic debates (e.g., in dedicated journals and conferences). One possible reason for this state of affairs is a failure of sport scientists to critically engage with new theoretical developments in more mainstream scientific disciplines (and subdisciplines) such as, for example, sociology, educational sciences, economy, political sciences, gender studies, history or philosophy.

Linking sport research to multiple life and policy domains is vitally important and should, as such, include studies from a broad inter-sectoral perspective. This would also require a need for “*different disciplines working jointly to create new conceptual, theoretical, methodological and translational innovations that integrate and move beyond discipline-specific approaches to address a common problem*” (Sparkes & Smith, 2014, p. 242). Such a collaborative and collective approach has been described as transdisciplinary research and can lead to the development of new theories, synergies of methods in relation to sport and social inclusion (Sparkes & Smith, 2014).

This thematic issue aims to advance our scientific understanding about sport and development by adapting both a transdisciplinary and intersectoral perspective. We welcome papers from the broad applied fields of health, education, social/youth work, management, crime and rehabilitation, which focus on programs, policies and broad issues in relation to sport and development.
